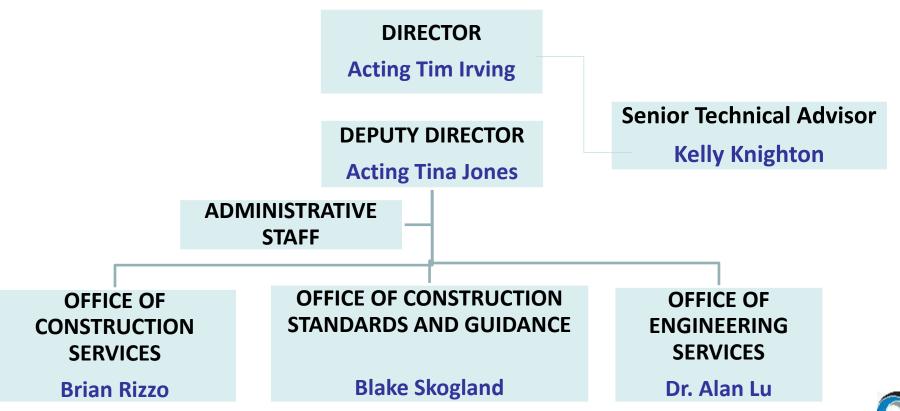

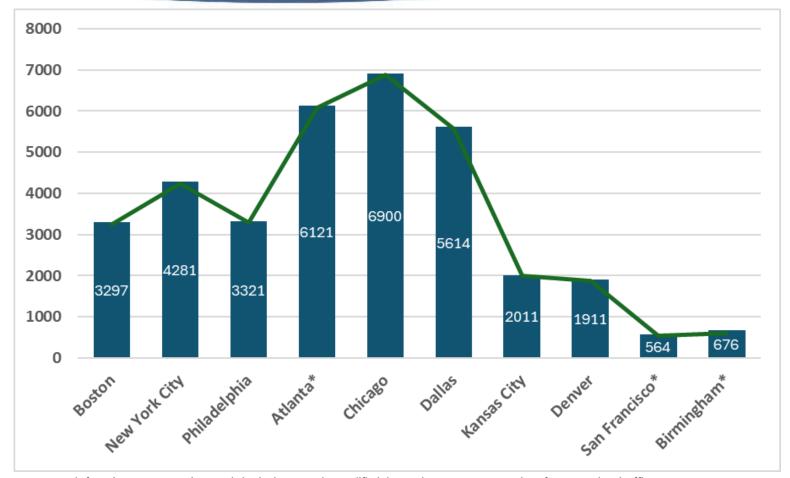

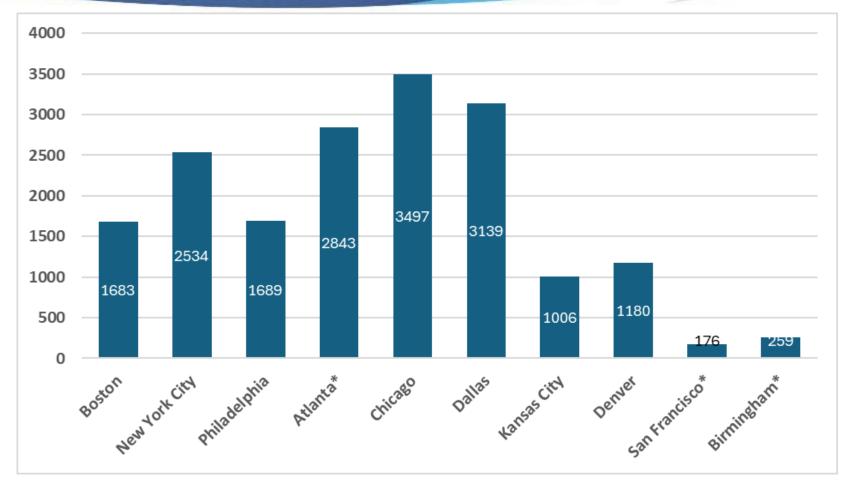

## FY24 All Inspections by Region Nation Total: 34,346



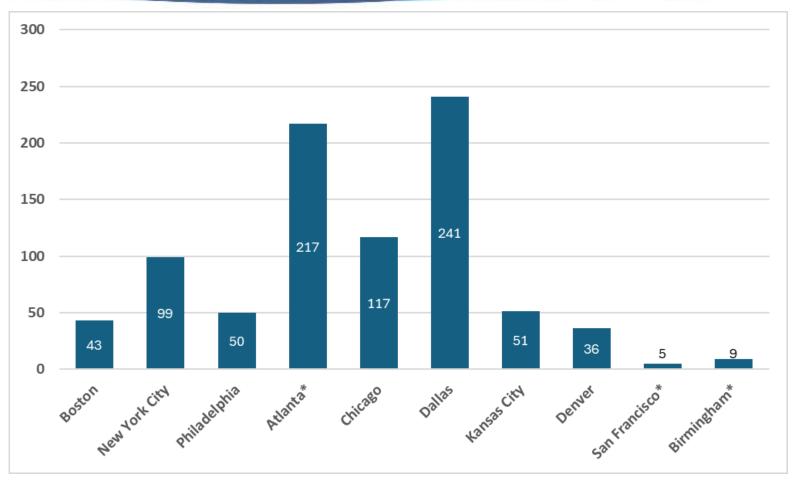


## FY24 Construction Inspections Nation Total: 18,006



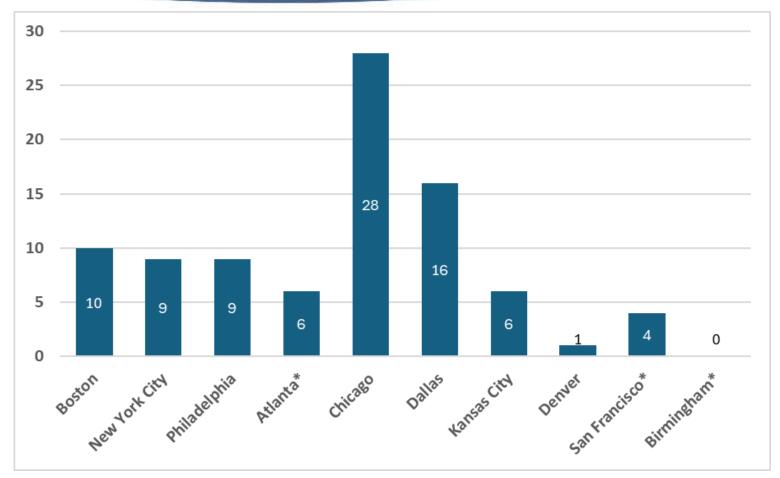


### FY24 Fatalities by Region Nation Total: 868

# Proposed Personal Protective Equipment Fit

- Proposal would revise construction standards to include explicit requirement that PPE must fit workers properly
- Proposed revisions would make construction standards consistent with general industry and maritime
- Proposal would address concerns of women in construction.





# **Employee Representation During OSHA Inspections**

The rule became effective on May 31, 2024 and clarifies that a non-employee representative may be reasonably necessary based upon skills, knowledge or experience.

- Knowledge or experience with hazards or conditions in the workplace or similar workplaces.
- Language or communication skills to ensure an effective and thorough inspection.
- OSHA regulations require no specific qualifications for employer representatives or for employee representatives who are employed by the employer.

#### 5 Ways Construction Employers Can Create Safer Workplaces for Women

More than 390,000 women work in construction and extraction occupations, an 11% increase since 2017, More women are attracted to the high-paying, high-quality careers offered by the construction trades, which is much needed at a time when the construction industry faces large workforce demands in order to undertake ambitious and historic federally-funded infrastructure projects. But despite this growth, gender and racial discrimination remain widespread and many women still face challenges navigating these male-dominated occupations - including threat to their safety. Not only do all workers deserve respectful workplaces free of discrimination, they deserve to go to work in a safe and healthy environment.

Here are five ways employers can create safer and better workplaces for all workers, including women:

Provide Properly Fitting Personal Protective Equipmen

Women's safety on the job is undermined when safety measures, such as providing personal protective equipment (PPE) for diverse bodies, are not implemented in favor of a one-size-fits-all approach. A recent survey of of tradeswomen and non-binary tradespeople found that nearly three in ten report never or rarely being provided gloves or safety equipment in sizes that fit them. According to another survey 3, 89% of tradeswomen said they had difficulty accessing PPE that fits and 77% reported they were exposed to unnecessary hazards because of ill-fitting PPE. In response, the Occupational Safety and Health Administration (OSHA) issued a notice of proposed rulemaking to ensure that all employees have PPE that fits properly

#### What does the *Total Worker Health* approach look like in practice?

Implementing a *Total Worker Health* approach is an ongoing effort that prioritizes workers' safety, health, and well-being. The aim is to create a robust culture of safety, worker protection, and greater health opportunity. This approach consists of a mix of interventions, policy changes, and practices.

This approach often starts with an organizational focus, assessing challenges to keeping workers safe and healthy. Following that are changes to the built environment, policies, and programs.

Programs aligned with the *Total Worker Health* approach are voluntary and participatory. They give workers a voice in the conditions of their work and a say in workplace offerings. Implementation can be incremental and is best driven by worker input using the participatory approach.



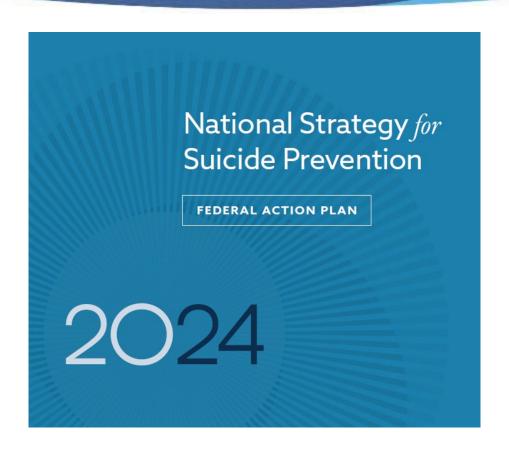

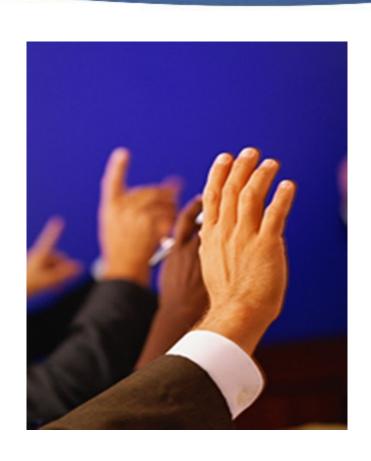
