More than 20 million US workers rely on PPE; Inadequate PPE protection for women needs to be addressed.

The representation of women continues to grow, or women already make up significant percentage in several occupational sectors: healthcare, public safety, construction, and mining.¹

Women remain an underserved PPE user population, potentially exposing them to additional health and safety risks on the job.^{2,3}






Ill-fitting PPE can lead to injuries and has been linked to increased stress.

Examples of inequitable protections for female workers include:

- Issues related to fit, discomfort, and inadequate availability of PPE
- Limited access to properly sized PPE, forcing women to adapt, wearing ill-fitting PPE, or skip PPE without appropriate options.



NIOSH has been learning about challenges related to PPE protection for female workers.

FRN, 2021-2022 (39 submissions)

Needs & challenges identified: construction sector

Fall protection equipment

- Women and pregnant workers (size, fit)
- Atypical sizes and body shapes
- Training, labels, and instructions in other languages and using pictures

PPE type mentioned

• Durable pants, fall arrest harness, coverall, Tyvek suits, non-gender specific rain gear, reflective safety vest, boots/shoes/gloves, hearing protection, flame-retardant clothing

Other issues

- Outdoor work activities (cooling, lightweight, illumination)
- Some PPE are not available in the market (e.g., P100 with 6CFM)
- Contractors may not make proper PPE available for many reasons (e.g., not prioritize PPE faced with limited supply for various sizes, lack of resources to purchase PPE for each worker)

NIOSH 2022 Workshop on Equitable PPE Protections

Participants: 1,000+ from PPE manufacturers, practitioners, federal agencies, labor and worker groups, and all individuals who are interested in this topic

Feedback revealed 4 primary themes:

- Size, shape, fit, functionality, and safety of PPE for end users
- The need for interdisciplinary collaborations and partnerships
- Gaps and challenges related to PPE regulations and standards
- Limitations of PPE manufacturing

NIOSH 2022 Workshop on Equitable PPE Protections

Construction-specific discussions

- A presenter cited "fit" as the number one concern expressed by 3,300 tradeswomen in construction.
- 29 Code of Federal Regulations Part 1926.95 requires that the employer provides PPE but with no explicit requirement that the PPE fits workers.
- It was suggested that NIOSH continue to partner with employers and employees to help close some of these gaps as well as engage in research.
- Enforcement and accessibility issues are observed in construction especially during COVID.

Equitable PPE for Women Study Objectives

- Identify driving factors and barriers for equitable PPE protection for women in PPE use, availability, accessibility, acceptability, and knowledge.
- Draft a methodological framework to identify and mitigate site- and job-specific barriers for equitable PPE protections
