- 1. Progress on actions from last meeting
 - a) DR to talk to Robin about the possibility of doing a campaign in California (and get a cost for the heat campaign).
 - -AJIM issue has articles on campaigns: Special Issue: Moving Research to Practice in Construction Safety and Health AJIM Volume 58, Issue 8 Pages 807 914, August 2015
 - Robin will talk to State Compensation Insurance Fund in California (SCIF) to see if there is interest in running an ergonomics campaign. David will follow-up with Robin.

Falls campaign- hired Hanon group, funded by NIOSH and CPWR- 3-year project. Conducted a planning/environmental study and evaluation of the campaign results.

Heat campaign- estimated cost of \$1mil (<u>Charlotte to check</u>). \$\$ came from legislation and in-kind monies. Run by SCIF.

Scott mentioned he and Billy Gibbons delivered ergonomics training to SCIF but it fell under the now defunct California Loss Control Dept.

b) SS to talk to folks at WA state about issues around the ergo standard and lessons for moving toward an ergo campaign

Scott is trying to reach Lauren Murphy- may see if Jack Dennerlein has contact information.

<u>Scott will reach out to Mandy Kymes (?sp)</u> who is associated with the AGC for Washington State, and has developed an ergonomics program for the AGC.

c) EB will reach out to get information on OH BWC to assess interest in a campaign if there's a need based on the September call.

Eileen will wait until we decide if California is interested in the participating in the campaign before contacting OH.

 - a. Question about whether the small study will be used to design the campaign or deliver the campaign-depends on the focus
 - b. Need to get a better handle on what we know
